

Dear Supporters,

Like the weather, the campaign to Protect Richardson Grove is heating up. As deadlines approach, the effort to protect the awesome ancient redwoods lining the highway 101 corridor through the Park from the ravages of Caltrans' "Realignment" Plan is shifting into high gear!

Caltrans wants to widen the road and lengthen its curves to allow bigger trucks to go faster through the Grove. The project would bring this section of the road up to Surface Transportation Assistance Act standards. It would lift current restrictions on truck lengths and mandate other unsavory changes, such as huge turnouts and roadside truck stops.

This is our State Park, not a corporate speedway.

Many of the trees at risk are 1,000 years old or older, with diameters of up to 18 feet. Redwood tree roots interlock with each other and many touch the existing roadway. The widening project will cut and rip redwood roots up to two inches thick and excavate to depths of 36", then backfill the holes with a porous concrete mixture topped with hot asphalt.

Since these small roots are feeder roots, the damaged trees could have trouble transporting water to their upper branches, compromising their structures. In addition, the concrete fill would leach a base pH into the soil of these acid-loving trees. Toxic compounds from the existing road materials laced with lead and oil and other chemicals from vehicle brake linings would be stirred up and spread around by the construction work. Not healthy!

Is this more than you ever wanted to know about the intricacies of redwoods' well-being? Here's what we're doing to stop this disastrous project from putting trees in danger. Ecotrans, a Redwood Nation EF! affinity group, is back to take on Caltrans a second time! In 1997, Ecotrans, in a coalition of four local groups, won a lasting victory when Caltrans agreed to stop the spraying of roadside herbicides in five counties. At that time Caltrans was the largest user of herbicides in California. Today, mechanical removal creates more and safer jobs for workers. Now, Ecotrans has renewed itself with updated nonviolence training. On Memorial Day it held its first demo at Richardson Grove!

Wearing orange vests and hard hats labeled "Ecotrans EF!," activists demonstrated at the north end of the Grove, holding signs with a message based on the Simon & Garfunkle song: "Feelin' Grovey" (I mean groovy). Spaced at intervals along the road like old Burma Shave ads, the signs read: "Slow Down—You Move—Too Fast—You Gotta –Make The—Forest Last!

Another large sign broadcast a simpler version of the group's message. The sign showed an enormous truck inside a red circle with a diagonal red line through it and the words: "CALTRANS: NO WIDENING!"



Big Trees or Big Trucks?

Redwood Nation Earth First! has been working as a part of the Coalition to Save Richardson Grove. The Coalition includes a broad range of community groups and individuals united in opposing the project. Environmental Protection Information Center and Citizens' Alternatives to Toxics, affectionately known as EPIC and CATs, have teamed up with Center for Biodiversity and private parties to file two lawsuits against the plan, one each in the Federal and State courts.

The plaintiffs recently applied for a Preliminary Injunction. A ruling is expected by July 1st or earlier. If unsuccessful, Caltrans could start the bidding process within 30 days, and once a contract is awarded, the sinister plot could begin by early August.

That's why a Headwaters-style **rally is planned for June 22, in Sacramento** to get the eyes of the media and the ears of the Governor focused on Realignment's critical consequences for the redwoods. While others lobby, we'll use

In early spring, Redwood Nation EF! extended its outreach by canvassing in Mendo and Humboldt counties. This effort resulted in a big jump in support and sign-ups for the
